Full payment is required to confirm your registration. Registration is not complete until both the registration form and your payment are received.

We ask that only working participants can have dogs in the building during the seminar. The strictness of this policy depends on the location of the seminar and space availability. All dogs must be friendly with people and dogs, and quiet in a crate or ex-pen. Noisy or disruptive dogs will be asked to be moved to your vehicle. Dogs must be on leash and supervised at all times.

- Cancellation must be no less than 45 days prior to the start date, full refund, minus \$25.00 administration fee.
- Cancellation between 45 -15 days prior to the start date, 50% refund except for programs less than \$50.00. Programs with tuition less than \$50.00 will be refunded the full amount minus \$25.00 administration fee.
- Cancellations 14 days or less before the course, No Refunds.
- Transfers from working to auditor spots will be reimbursed the difference in tuition based on the above policies.

This policy applies to participants/auditors that must withdraw for any reason including but not limited to injury, illness, emergency and personal or work-related reasons. Registration is not transferable. This policy is without exception.

Participants asked to leave the event/property because her/his dog is dangerous, disruptive or unmanageable will not be refunded any part of the tuition.
